POINT ON ASSOCIATION BUSINESS

About the Association Billing and Collection Policy

Our association adheres to a collection policy to ensure our bills get paid and that we make adequate contributions to our reserves account. Our collection policy is designed to be fair to all residents and collect HOA dues in the same manner from each resident. Our collection policy also provides for a series of steps that the association must take when a resident becomes behind on payments.

On the first of each month, invoices are generated and sent either by regular mail or email to each homeowner and/or resident for their HOA dues, RV space rent, storage space rent and/or non-compliance fines. It is our policy to bill homeowners for HOA dues, even if the home is a rental, regardless of who actually pays the dues to the association. We have enacted this policy because if the dues are not paid, they are ultimately the responsibility of the homeowner, and the association will pursue the homeowner for payment of HOA dues.

The association accepts either cash or check payments. Unfortunately, we are not set up for credit or debit card payments. Many residents have set up online bill pay to the association through their bank, and their banks mail us a paper check that we deposit into the association account. The association charges a \$25.00 fee on all returned (bounced) checks. In order to ensure that your payment is credited correctly, please ensure that the property address is on the check.

Payments are due 30 days after the date on the invoice and are considered late after that point. The association will charge a late \$25.00 late fee once an invoice is 30 days PAST due (30 days past the due date on the invoice.) The late fee is charged on a monthly basis for invoices that are 30+ days past due.

Also, once an account is 30 days PAST due, the association will suspend access to the HOA amenities. This also applies to renters whose landlords are behind on their HOA dues. The association will deactivate pool fobs and not allow for clubhouse rental until the account is brought current.

The association will notify homeowners that their account is delinquent by sending late notices and copies of statements with the invoices.

Once an account exceeds 60 days PAST due, the association will send a request for a

payment plan. If a homeowner agrees to and abides by a payment plan, the association will not charge late fees on any overdue balance. If a homeowner does not enter into a payment plan, rather merely mails in payments over and above the invoice amount, the association will continue to collect late fees on overdue balances.

Once an account is exceeds 90 days PAST due, the association will send a certified letter to the homeowner informing them that they have a set amount of time to either pay their overdue balance or enter into a payment plan with the association. If the homeowner fails to either pay their bill or set up a payment plan, the account will be turned over to our attorney or collection agency for final collection or further proceedings.

Of course, it is the goal of the association that all invoices are paid in a timely manner. Our budget is designed with that goal in mind. If all residents pay their invoices on time, the association should have enough money to keep our neighborhood a place all of us are happy to call home.

The next board meeting will be held Wednesday, April 15th at 6:00pm in the clubhouse.

Although none of us wants to "snoop" on our neighbors, there are some things that just do not make sense. Please watch out for these activities in our neighborhood and report them to the police non-emergency number 541-776-7206.

- Someone running from a car or home.
- Someone screaming. If you can't explain

- the screams, call law enforcement and report them.
- Someone going door-to-door in the neighborhood or looking into windows and parked cars.
- Someone asking about current or past residents.
- Someone wandering through the neighborhood with no apparent purpose.
- Unusual or suspicious noises that you cannot explain, such as breaking glass or pounding.
- Vehicles moving slowly without lights or without an apparent destination.
- Business transactions conducted from a vehicle. This could involve the sale of drugs or stolen goods.
- Someone walking or running while carrying property at an unusual time or place.

- A stranger entering or removing property from a neighbor's home when they might not be home.
- A stranger in a car who stops to talk to a child.

Also, please remember that if you have an emergency, please call 911 immediately for police response.
